Woodrow joined M&T Bank in 2013 to oversee its enterprise-wide anti-money laundering program. As she immersed herself in the bank's operations and structure, she rose to become Chief Human Resources Officer in 2020. In addition to leading efforts to adapt to new workplace needs during the pandemic, Woodrow focused on staffing, recruiting, leadership development and employee relations for M&T's more than 22,000 employees across the Northeastern U.S. In 2023, Woodrow was appointed Chief Administrative Officer, a role she will continue to hold while serving as Western New York Regional President. Woodrow is a member of M&T Bank's Executive Leadership Team.

In the community, Woodrow serves on the Buffalo Philharmonic Orchestra Board of Trustees. She is also Vice President of the Buffalo Prep Board of Directors, Chair of the Westminster Foundation Board of Directors and a 2019 graduate of Leadership Buffalo. Through her personal commitment to mentorship, Woodrow is steadfastly dedicated to improving the lives of others.
