- The option granted includes a total of 5,434 shares. 1,811 of the shares are exercisable on or after January 31, 2019; an additional 1,811 of the shares are exercisable on or after January 31, 2020; and the remaining 1,812 shares are exercisable on or after January 29, 2021.
- The option was granted under an equity incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the option.
